In the event of default, the undersigned shall be responsible for all costs of collection, damage and expenses including actual attorney's fees & costs, whether or not litigation is pursued.

Special factory orders are non-refundable and must be prepaid in advance.

Arbitration Clause - all parties to this agreement hereby agree that in the event of a dispute under this agreement or for any dispute that arises out of this agreement the parties shall resolve their dispute through arbitration. The arbitration shall take place at Los Angeles office of the American Arbitration Association or otherwise the nearest office of the American Arbitration Association in Los Angeles area. The result of the arbitration shall be final and binding upon all parties.
